## <u>TRUTH:</u>

There is no such rule in Softball.

The "tie" is up to the ump discretion as to who made the best effort to make the play, the defense or offense.

## <u>MYTH</u>:

Softball was derived from Baseball.

## TRUTH:

Although many people assume that softball was derived from baseball, the sport's first game actually came about because of a football game.

The history of softball dates back to Thanksgiving Day of 1887, when several alumni sat in the Chicago, Illinois Farragut Boat Club, anxiously awaiting the outcome of the Yale versus Harvard football game. When Yale was announced as winner, a Yale alumnus playfully threw a boxing glove at a Harvard supporter. The Harvard fan swung at the balled-up glove with a stick, and the rest of the group looked on with interest.

The person who invented this game was a guy named George Hancock .This game, 112 years later, is known as the first softball game.

George tied the boxing glove so that it resembled a ball, chalked out a diamond on the floor, which gave it small dimensions than a regular baseball field to be able to fit in the gym, and broke off a broom handle to serve as a bat.

George, a reporter for the Chicago Board of Trade, jokingly called out, "Play ball!" and the first softball game commenced with the football fans using the boxing glove as a ball and a broom handle in place of a bat. Softball is a variant of baseball played with a larger ball on a smaller field. ... It was at various times called indoor baseball, mush ball, playground, softball, kitten ball, and because it was also played by women, ladies' baseball. The name softball was given to the game in 1926, because the ball used to be soft.
